Hon'ble External Affairs Minister, (EAM), Dr. S Jaishankar delivered remarks At First 'ASEAN Future Forum' on 23 April 2024:

Hon'ble External Affairs Minister, Dr. S Jaishankar virtually delivered remarks At First 'ASEAN Future Forum' hosted by Vietnam, with the theme of "Toward fast and sustainable growth of a people-centered ASEAN Community". Speaking at the Forum, EAM highlighted India's belief that, the strong and unified Association of South East Asian Nations (ASEAN) can play a constructive role in the emerging regional architecture of the Indo-Pacific. EAM highlighted that, the synergy between 'India's Indo-Pacific Oceans Initiative' (IIPOI) and the ASEAN Outlook on Indo-Pacific (AOIP) provides a strong framework of cooperation, including, addressing challenges to comprehensive security. EAM further added that ASEAN is at the heart of India's Act East policy and is a crucial pillar in India's wider Indo-Pacific mission. He emphasized that the time has come for the Global South to present its perspective and assume a greater role in international affairs. EAM remarked that it is vital that freedom of navigation, overflight and unimpeded commerce are respected and facilitated by all. Highlighting the role of QUAD, Dr. Jaishankar said that QUAD leaders have been consistent in extending their unwavering support for ASEAN centrality.


High Commissioner, Mr. B.N. Reddy join KL20 Interaction over Dinner in conjunction with KL20 Startup Summit chaired by Prime Minister of Malaysia, Mr. Anwar Ibrahim and joined by four Cabinet Ministers, investors and sovereign wealth funds on April 22. High Commissioner briefed about the transformative changes in India, launched by Prime Minister Shri Narendra Modi since 2016 in startup ecosystem in India- with India emerging as the third

largest startup hub in the world in a short period. High Commissioner also elaborated on key reforms resulting in about 500 startups in 2016 increase to 127,000 and highlighted the presence of 10 Indian startups, including 4 unicorns in Malaysia. HC also listed next steps in deepening startup engagement between India and Malaysia, including launch of India-Malaysia Startup Bridge. HC also conveyed that Indian startups are keen to make Malaysia to become a hub for their activities in the Southeast Asia region. The Event was coordinated by Mr Nitin Jaiswal, Head, Asia-Pacific (ER), Bloomberg. HC also met mr. What's New - Business & Investments News in India

1. India takes top rank in world artificial intelligence race

According to a recent report by NetApp, a prominent data infrastructure company, nations such as India, Singapore, the United Kingdom, and the United States (US) are leading the charge in AI adoption and innovation. The report, conducted in collaboration with Savanta, surveyed over 1,300 executives across ten countries to gauge AI implementation status in various industries. It revealed that 60% of companies in leading countries have already initiated and operationalized AI projects...read more

2. India global services export to reach US\$ 800 billion by 2030: GoldmanSachs

Goldman Sachs forecasts India's services exports to surge to US\$ 800 billion by 2030, a significant rise from US\$ 340 billion in 2023, bolstering the external sector and curbing rupee volatility. The report titled 'India's Rise as the Emerging Services Factory of the World' projects services exports to represent around 11% of GDP by 2030, compared to 9.7% in 2023. India's contribution to global services exports has more than doubled in the last 18 years, with the emergence of global capability centers (GCCs) driving growth. High-value services are anticipated to fuel demand for top-tier discretionary spending, stimulating domestic commercial and residential real estate activity...read more

3. India ranks 4th in global military spending at US\$ 83.6 billion in 2023: Report

In 2023, India ranked as the world's fourth-largest military spender, allocating US\$ 83.6 billion towards modernizing various weaponry and combat systems, per a Stockholm International Peace Research Institute (SIPRI) report. India's military expenditure witnessed a 4.2% increase compared to 2022, reflecting its strategic focus on enhancing defence capabilities. Investments encompass fighter jets, helicopters, warships, tanks, artillery guns, rockets, missiles, unmanned capabilities, and other combat systems. India maintained its fourth position in 2022, with military spending amounting to US\$ 81.4 billion, representing a 6% surge from 2021 and a substantial 47% rise since 2013...read more

4. India recorded about 131 billion UPI transactions in FY24, says Minister of Finance

The Minister of Finance, Ms. Nirmala Sitharaman, announced at the 'Viksit Bharat Ambassador' event that India witnessed a remarkable surge in digital payments, with approximately 131 billion Unified Payments Interface (UPI) transactions amounting to US\$ 2.39 trillion in FY24. She highlighted the widespread adoption of digital payment technology even in rural areas, emphasizing that it's not just conglomerates but also ordinary citizens participating in these transactions....read more

5. Commerce Ministry working on infrastructure to achieve US\$ 1 trillion exports by 2030

The Department of Commerce, led by Additional Secretary Mr. Anant Swarup, spearheads efforts to identify critical infrastructure needs and strategic sectors to realize India's US\$ 1 trillion merchandise exports target by 2030. Collaborating with the Asian Development Bank for a comprehensive study, he emphasizes the importance of assessing the nation's capacity to accommodate an estimated US\$ 2.5 trillion in export-import (EXIM) trade, with US\$ 1.5 trillion in imports...read more

6. Renewable Energy accounted for 71% of India's new Power generation in FY 24

In India during FY 23-24, Renewable Energy (RE) contributed more than 70 per cent of the 26 GW (GigaWatt) of new power generated in the country. India's total installed energy capacity has now reached 442 GW, with RE comprising approximately 33 per cent (144 GW) and hydro contributing 11 per cent (47 GW), according to the report by CEEW Centre for Energy Finance (CEEW-CEF). In line with India's ambitious renewable energy targets, RE auctions soared to a record high, reaching approximately 41 GW of auctioned capacity in FY24... read more

7. .E-commerce market to hit US\$ 325 billion by 2030, rural India to lead growth

A report by Invest India suggests that India's e-commerce landscape is on the brink of monumental growth, projected to reach US\$ 325 billion by 2030, with the nation's digital economy soaring to US\$ 800 billion. With online shopping currently constituting around 7% of India's retail market, the potential for expansion is vast, driven by factors such as high internet penetration, affordable internet services, and a surge in rural smartphone users. India's internet user base, the second largest globally at 881 million, positions it to become the third-largest online retail market by 2030, with an estimated 500 million shoppers...read more

 key attraction for international travelers seeking holistic rejuvenation and well-being
 experiences. The market potential for wellness tourism in India is substantial, with an estimated
 worth of US\$ 19.43 billion in 2024, projected to reach US\$ 26.55 billion by 2029, indicating a
 significant growth trajectory.
- India's appeal as a global wellness destination is further enhanced by its well-developed infrastructure, modern medical facilities, and convenient travel connections, making it an attractive choice for wellness seekers worldwide. 1. Sri Venkateshwara Swamy Temple, Tirumala

The Sri Venkateswara Swami Temple siatuated in the Tirumala hills, Tirupati, is dedicated to Venkateswara, an incarnation of Vishnu, revered for his divine presence and believed to alleviate the trials of Kali Yuga. Visitors are often captivated by the temple's intricate architecture, which showcases a blend of Dravidian and Vijayanagara styles. The temple is renowned for its unique practice of 'tonsure,' where devotees offer their hair as a symbolic gesture of surrender and devotion.



2. Borra Caves

Borra Caves, nestled within the picturesque Araku Valley, reveal a hidden world adorned with unique formations like the "Shiva-Parvathi" stalagmite. believed to represent Lord Shiva and Goddess Parvati. This natural wonder is also homalakona Falls, nestled amidst the lush forests of Chittoor district in Andhra Pradesh, cascades gracefully from a towering height, creating a mesmerizing spectacle of nature's grandeur. Visitors are enchanted by the serene surroundings and the soothing sound of water echoing through the verdant valley to rare species like the golden gecko, adding to its allure as a fascinating destination for both nature enthusiasts and spiritual seekers.



3. Sri Veerabhadra Swamy Temple, Lepakshi

Sri Veerabhadra Swamy Temple in Lepakshi boasts one of India's largest monolithic Nandi sculptures, carved from a single granite rock. This architectural marvel features intricate carvings, including the famous "hanging pillar," which remains suspended without support, baffling visitors with its engineering ingenuity. Legend has it that the temple was built at the spot where Jatayu, the mythical bird from the epic Ramayana, fell while trying to save Sita from Ravana, adding a mystical dimension to its significance.

4. Dhyana Buddha Statue Amaravathi

The Dhyana Buddha Statue in Amaravathi stands tall at 125 feet, making it one of the tallest monolithic statues of Lord Buddha in India. Crafted from a single block of granite, this majestic statue exudes serenity and tranquility, inviting visitors to contemplate and meditate in its peaceful presence.



5. Golconda Fort

Golconda Fort in Hyderabad is famed for its acoustic marvel, where the handclap at the entrance can be heard at the highest point, serving as an ancient warning system. This historic fortress also houses the secret Fateh Rahben cannon, renowned for its massive size and remarkable engineering, adding to its allure for history buffs and adventurers alike. Visitors can also marvel at the fort's ingenious water supply system, which utilized sophisticated hydraulic engineering to provide water even during sieges.



6. Coringa Wildlife Sanctuary

Har Ki Pauri, located in Haridwar along the banks of the Ganges River, is a revered ghat and a sacred pilgrimage site in India. Known for the daily Ganga Aarti, this iconic stepwell is believed to be the spot where Lord Shiva left his footprint. Pilgrims and visitors gather at Har Ki Pauri to participate in religious ceremonies, take a holy dip in the Ganges, and experience the spiritual ambiance of this historic place.



7. INNS Kursura (S20) Submarine Museum

Moored in Visakhapatnam, the IINS Kursura (S20) Submarine Museum provides a rare peek into submarine operations, showcasing naval ingenuity and expertise. Being the sole submarine museum in South Asia, it serves as an educational gem, inviting guests to delve into the submarine's mechanics and its pivotal role in maritime history, all housed within its steel hull-turned-exhibit space.
