# India chairs G-20 Presidency: Hon'ble Prime Minister of India addressed G20 University Connect Finale:

Hon'ble Prime Minister of India, Shri Narendra Modi addressed the G20 University Connect Finale programme in New Delhi on 26 September 2023. The G20 University Connect initiative was undertaken with the aim to build an understanding of India's G20 Presidency among India's youth and enhance their participation in the different G20 events. The Prime Minister also released 4 publications on the occasion, namely The Grand Success of G20 Bharat Presidency: Visionary Leadership, Inclusive Approach; India's G20 Presidency: Vasudhaiva Kutumbakam; Compendium of G20 University Connect Programme; and Showcasing Indian Culture at G20. During his address at the gathering, the Prime Minister underlined that India's diplomacy has scaled new heights in the past few weeks. He touched upon the BRICS Summit that took place in South Africa before the G20 where six new nations were included as its members with India's efforts. Talking about the transformative decisions of the G20, the Prime Minister made references to the Inclusion of the African Union in G20 as a permanent member. International Biofuel Alliance led by India, India Middle East European corridor, to name a few.



#### 1st P20 Summit under India's G20 Presidency Concludes:

The first ever G20 Parliamentary Speakers' Summit, (P20 Summit), hosted by India witnessed its concluding session in New Delhi on 14th October 2023. The parliamentarians from across the world reaffirmed their commitment to continue their joint work to make an effective and meaningful parliamentary contribution to the G20 process. Earlier, the ninth edition of the P20 Summit was inaugurated by Hon'ble Prime Minister Shri Narendra Modi on 13th October. The two-day summit was preceded by a Parliamentary Forum on Mission LiFE on October 12 2023. the Presiding Officers unanimously adopted a Joint Statement, under the Chairmanship of the Speaker of Lok Sabha (House of People), Shri Om Birla.

#### Special Allocation of White Rice to Malaysia:







Pursuant to the request received from the Government of Malaysia for allocation of special quota of white rice by India on Government to Government basis and strong bilateral ties in food & agricultural sector between the two countries, India has approved export of 170,000 metric tonnes (MTs) of Non-Basmati White Rice to Malaysia on

October 18, 2023 as mark of special friendly gesture. The decision of India to allow special allocation of white rice to Malaysia was conveyed by H.E. Dr. S Jaishankar, Hon'ble External Affairs Minister of India over a telephone call with H.E. Datuk Seri Dr. Zambry Abdul Kadir, Hon'ble Minister of Foreign Affairs of Malaysia on October 18, 2023. Datuk Seri Dr. Zambry expressed his appreciation to the Government of India for extending support to the Malaysian people in view of the current supply situation. The decision by India is reflective of the close ties between India and Malaysia and in line with India's continued policy of supporting efforts of governments in the friendly countries towards safeguarding domestic food security.

#### **Engagements of High Commission of India Kuala Lumpur**

High Commissioner, Mr. B.N. Reddy met the Chief Minister of Melaka, Mr. Ab Rauf Yusoh on September 11. They discussed about successful Indian investments in Melaka including Recron Malaysia and Manipal University Malaysia, and also on further strengthening this collaboration in investments, tourism and connectivity. Mr. Shanmugam Ptcyhay, EXCO Member also joined the meeting. During his visit to Melaka, High Commissioner visited Recron Malaysia plant, world's largest integrated polyester & textile complex, owned by India's reliance group on September 11. Recron Malaysia is present in Malaysia since 2007, becoming an example of India's investment in Malaysia, with exports of over US\$ 700 million per annum. During the visit, High Commissioner also visited the Manipal University Malaysia at Melaka and met Vice Chancellor Prof Dr. Patrick, Advisor Prof Dr. Jaspal



Singh and the senior faculty team on September 11. Started as Manipal Melaka College in 1997 in collaboration with Manipal Academy of Higher Education, it has significantly expanded to become a University College. Manipal University Malaysia is an important part of India-Malaysia collaboration in higher education in medical sector.







Malaysian Airlines is expanding its footprint in India this year, with the commencement of three new services between Kuala Lumpur (KUL) to Amritsar (ATQ), Thiruvananthapuram (TRV) and Ahmedabad (AMD), effective November 8, November 9 and December 1 respectively. Malaysia Aviation Group, (MAG) managing director, Datuk Captain Izham Ismail said the expansion would bring Malaysian Airlines' point-to-point connectivity from Kuala Lumpur to India to nine key hubs, thereby providing passengers with enhanced options and flexibility for travel between the two countries. The airline currently operates direct flights to New Delhi, Bengaluru, Mumbai, Chennai, Hyderabad and Kochi. The three new routes into Indian network will provide added convenience for travellers. He said this in conjunction with the Malaysian Association of Tour and Travel Agents (Matta) Fair, which happened from September 1-3.

On 15 September, High Commissioner met Officers from Malaysian Army, Major, Nornie Fathma binti AB Rahman & Royal Malaysian Air Force Major, Marina binti Mahmood who attended the 1st ever 'UN Female Military Officers Course For ASEAN Countries' at Centre for UN Peace Keeping (CUNPK) in New Delhi. The course was held from 18-29 September 2023, and will see participation from all ASEAN countries; and is centred on UN Peace Keeping Operations with specific focus on Gender Parity & role of women in UN Peace Keeping operations.





High Commissioner attended the 45<sup>th</sup> National Tirumurai Recital Competition organised by the Malaysia Hindu Sangham at Seremban on September 16, 2023. High Commissioner lauded the efforts of the organisers and the participants for their passion & commitment to carry forward their rich Tamil cultural heritage. Earlier in the day, the Officials of the Mission made a presentation on educational opportunities in India. Parents and students were keen to learn about

the study in India and its newly launched portal that allows a single window for all foreign nationals aspiring to study in India's premier educational institutions.

High Commissioner interacted with a 23-member delegation from Odisha, comprising off academicians & researchers visiting Malaysia, as part of Bharat Culture Tour of South East Asia 2023. The delegation also met other members from Malaysia Odia Association, Oriya Association of Malaysia, Malaysia-India Heritage Society, GOPIO Malaysia and Netaji Welfare Foundation at a special



"Meet and Greet" Session held at Netaji Subash Chandra Bose Indian Cultural Centre in Kuala Lumpur on September 16, 2023. Odisha academicians were led by Mr. Kamalesh Dash, Rastriya Samparka Pramukh, Akhila Bharatiya Itihasa Sankalana Yojana. Discussions centred on the age-old connect between ancient Kalinga & South East Asia, including in Malaysia & ways to reinforce cross cultural linkages between Odisha & Malaysia. The Presence of over 5000 Odiya-speaking Malaysian Indian community serves as a living linkage of this connect.

High Commission organised the ITEC Day in Kuala Lumpur on 20 September 2023. The Deputy Minister of Foreign Affairs of Malaysia, Mr. Mohamad Alamin delivered the keynote Address at the Event. The Minister stated that, the Malaysian Technical Cooperation Programme (MTCP) and the Indian Technical and Economic Cooperation Programme (ITEC) have benefited the citizens of both countries apart from strengthening bilateral ties. He added that, the collaboration between MTCP and ITEC have facilitated continuous skill development and competency enhancement among their citizens to meet the demands of the modern world. He further added that, India's ITEC and MTCP allow the two countries to benefit from the complementarities and comparative advantages. The High Commissioner, Shri B.N. Reddy welcomed the participants and highlighted the many benefits of the ITEC programme.





High Commissioner delivered a special address at the second World Digital Economy & Technology (WDET) Summit held at Penang, by KSI on 21 September 2023. Inaugurated by H.E. Tun Ahmad Fuzi Abdul Razak, Governor of Penang, the WDET Summit was attended by representatives from 16 countries. Indian IT companies including Tata Consultancy Services (TCS) also attended the event. High Commissioner spoke on digital public infrastructure (DPI) in India and it's transformative effect on economy, governance and citizens' lives. HC highlighted how India is leading the world in DPI and is closely working with Government of Malaysia on various initiatives involving DPI.





High Commissioner met Gs. Tuan Haji Azlikamil Napiah, Director General Malaysian Space Agency (MYSA) in Kuala Lumpur on 25 September 2023. They discussed strengthening cooperation between India-Malaysia in space sector, including capacity building, collaboration in upstream and end-user projects. Director-General congratulated India & ISRO on its milestone achievement of Chandrayaan3 landing on Lunar South Pole. To strengthen India-Malaysia Enhanced Strategic Partnership, institutional cooperation between MYSA & ISRO covering all aspects of space sector, was also discussed.

The High Commissioner was the Guest of Honour at launching ceremony of GOPIO International Expo and Business Summit 2023 to be held on 1-3 December 2023. The launching ceremony was held on 18 September 2023. The Expo and Business Summit aims to bring together PIO Businesses across sectors from India, Malaysia and several

other countries for beneficial collaborations.



High Commissioner called on the Chief Minister of Penang, Mr. Chow Kon Yeow on 22 September 2023. They discussed on stronger business engagement between Penang and India, including collaboration with Digital Penang, skill development and capacity building, especially in digital technologies and also on semiconductor sector. Indian IT companies from CIIM are shortly expected to explore partnership with Digital Penang. High Commissioner met Penang State Exco, Mr. Wong Hon Wai. Discussions focused on rejuvenating historical and cultural linkages between India & Penang through a range of activities, including through the participation in the upcoming Georgetown Literary Festival in November 2023. On the same day, they also discussed about promoting tourism between Penang and India, keeping in view the large Indian diaspora and rising Indian expats in Penang.





High Commissioner met the President of Penang Muslim League, Mr. Haja Najmudeen Kader, and Heads of NGOs and other senior leaders, its Women and Youth wing members at the Main Office of Liga Muslim Pulau Penang on 22 September 2023. Discussion took place on their closer engagement with High Commission to celebrate the rich heritage of the Penang Indian Muslim community, and also early redressal of Indian nationals in distress as well as other community-related matters.



Armv General of Malaysia, Mr. Muhammad Hafizuddeain attended a regional Jantan military conference in New Delhi that deliberated on boosting cooperation to tackle security challenges. The 13th Indo-Pacific Armies Chiefs Conference (IPACC XII) from September 25 to 27 was jointly organised by the armies of India and the United States. Accompanying the army chief at the event were Major General Datuk Haji Semaon Haji



Marzuki, assistant chief of staff for operations and training, and Major General Datuk Ahmed Abu Bakar, assistant chief of staff for planning and development. Delegates from 38 countries participated in the conference where ideas and views were exchanged on the regional peace and security situation, including boundary disputes. The conference sought to promote mutual understanding, dialogue and friendship among the littoral partners. The main theme was "Together for Peace: Sustaining Peace and Stability in the Indo-Pacific Region".

#### What's New - Business & Investments News in India

#### 1. World Bank's G20 document praised India's financial inclusion via Digital Public Infrastructure

The World Bank found that India had reached financial inclusion targets in just six years, which would have otherwise taken at least 47 long years. The World Bank included this information in its G20 document. The Prime Minister also praised the country's robust digital payment infrastructure along with the spirit of the country's people. Furthermore, he added that it is equally a testament to the rapid progress and innovation...read more

## 2. India's first green hydrogen-powered bus, unveiled by Indian Oil Corporation (IOC), emits only water

India's first green hydrogen-powered bus that emits only water was launched by India's largest oil company, Indian Oil Corporation (IOC), as it takes the lead in developing unmatched instruments to replace fossil fuels. IOC will split water using electricity generated from renewable sources to make around 75 kg of hydrogen. Two buses that will do test runs across the national capital region will be powered by this hydrogen. While flagging off the buses, the Oil Minister, Mr. Hardeep Singh Puri, stated that hydrogen will be India's transition fuel for moving away from fossil fuels...read more

#### 3. India showcases thriving coffee industry at World Coffee Conference

Coffee enthusiasts and stakeholders worldwide had gathered in Bengaluru for the fifth World Coffee Conference (WCC) 2023. The four-day event, happening once every four years and being hosted in India for the first time, aimed to discuss sustainability through circular economy, regenerative agriculture, and innovation within the coffee industry. The conference has attracted more than 24,000 delegates from over 80 countries...read more

#### 4. India 72 places up in mobile download speed index after 5G launch: Report

India moved 72 places up in a global ranking of mobile download speeds as the launch of 5G services improved services over the past year. India's median download speed increased 3.59 times after 5G was launched in the country. The index puts India ahead of Indonesia, Bangladesh, Sri Lanka, and Pakistan and some Group of 20 (G20) countries, such as Mexico (90th), Turkey (68th), the UK (62nd), Japan (58th), Brazil (50th), and South Africa (48th)...read more

#### 5. India poised to grow at average 6.5 pc per annum over 2023-30: CEA

The Indian economy is poised to grow at an average of 6.5 per cent annually between 2023 and 2030, as per Chief Economic Advisor V Anantha Nageswaran. Speaking at the BCC&I Indo-Pacific Economic Conclave, Nageswaran said the global economy is going to witness a period of uncertainty, and India has to plug into the global supply chain and make itself attractive for the China-plus one strategy...read more

#### 6. India's renewable sector employed close to a million people in 2022

India is reported to have employed close to a million people in the renewable energy sector in 2022, according to a joint report by the International Renewable Energy Agency (IRENA) and the International Labour Organization (ILO). With about 4.66 lakh jobs, Hydropower was the largest renewables employer in the country, followed by solar PV, which had 282,000 people involved with on-grid and off-grid systems. Overall, India had about 0.99 million jobs in the clean energy sector. IRENA estimates that India had 201,400 jobs in grid-connected solar PV in 2022, up 47% from 2021. About 80,600 people work in off-grid solar space...read more

#### 7. India overtakes China in Times' World University Rankings

With 91 institutions, India is now the fourth most-represented nation in the Times Higher Education's 2024 edition of World University Rankings, overtaking China that saw 86 of its institutions in the coveted list. Indian Institute of Science (IISc) topped the list of 201–250 bands, followed by Anna University, Jamia Millia Islamia, Mahatma Gandhi University, and Shoolini University of Biotechnology and Management Sciences in the 501–600 band. The Times Higher Education World University Rankings 2024 include 1,904 universities across 108 countries and regions. This year's ranking analysed more than 134 million citations across 16.5 million research publications and included survey responses from 68,402 scholars globally...<u>read more</u>

## **Spotlight and Opportunities in India**

**Biotechnology Industry** 



- India is among the top 12 destinations for biotechnology worldwide. The Department of Biotechnology (DBT), under the Ministry of Science and Technology, has placed great emphasis on developing an ecosystem for the development of excellence and research in a variety of biotechnology fields in India.
- By creating and using a variety of tools at its disposal, such as vaccines, antivirals, diagnostic
  tests, and other tools, the biotechnology industry has been at the forefront of the fight against
  the Covid-19 pandemic. The pandemic has assisted the country in setting up the ideal
  ecosystem for production, sourcing, and exporting medical devices and vaccines.
- The number of biotech startup registrations has surged throughout the nation in 2021, with around 1,128 new startups registered, which is the highest in a single year since 2015.
   Estimates put the total number of biotechnology startups at 5,365, as of 2022. The number of startups is expected to touch 10,000 by 2024.
- India's bio-economy industry has grown from US\$ 10 billion to US\$ 80 billion in the last 8 years in 2022. The size of India's bioeconomy is estimated to be at US\$ 80.12 billion as of 2021, which is a 14.13% growth over US\$ 70.2 billion in 2020. India's bioeconomy contributes 2.6% to India's GDP, as of 2021. India's bioeconomy is poised to reach US\$ 300 billion by 2030.
- The largest portion of the Indian bioeconomy continues to be accounted for by biopharma. Biopharma accounted for 49% share of the bioeconomy, and its total economic contribution was estimated at US\$ 39.4 billion. By 2025, the vaccination market in India is projected to be worth US\$ 3.04 billion.
- It is expected that the bioeconomy in the country will reach the US\$ 150 billion mark by 2025. It is expected to contribute to roughly 3.3-3.5% of the country's GDP, up from 2.8% in 2021. Both consumption and exports of diagnostic and medical devices are expected to increase significantly in India. With the help of recombinant and biosimilar products, the therapeutics sector is predicted to generate US\$ 15 billion in bioeconomic activity by 2025.
