India chairs G-20 Presidency:

The 18th G20 Heads of State and Government Summit-9-10 September 2023:

The 18th G20 Heads of State and Government Summit was held in New Delhi, India on 9-10 September 2023. The G20 or Group of 20 is an inter-governmental forum, comprising 19 countries and the European Union (EU). G-20 represents 85% of the global GDP, over 75% of the global trade and about two-thirds of the world population. India viewed its G20 Presidency as an opportunity to give a voice to the concerns of the developing countries. The Summit was a culmination of all the G20 processes and meetings held throughout the year among ministers, senior officials and civil societies. A G20 Leaders' Declaration was adopted at the conclusion of the New Delhi Summit, stating leaders' commitment towards the priorities discussed and agreed upon during the respective ministerial and working group meetings.



Prime Minister Shri Narendra Modi's remarks during the G-20 Leaders' Summit:

During the inaugural session of the two-day G20 Summit, Prime Minister stated that, India's G-20 presidency has become a symbol of inclusion, both within the country and beyond. Prime Minister also remarked that, the African Union (AU) had been granted permanent membership in the Group of 20 largest economies (G20) worldwide. The announcement marked the AU's accession as a new member of this prominent global organization, consisting of 55 nations. Prime Minister chaired the Session on 'One Earth', 'One Family' and 'One Future', covering a range of issues of prime concern to the world community, including furthering strong, sustainable, inclusive and balanced growth. In his address, PM Shri Modi urged world leaders to overcome "trust deficit" caused by war. India's success in digital penetration to be shared to benefit all ASEAN member countries:

Prime Minister of Malaysia, Dato' Seri Anwar Ibrahim has suggested India's success in digital penetration to be shared to benefit all ASEAN member countries, especially in digital banking and finance, as well as rural areas. In this regard, Prime Minister Dato' Seri Anwar stated, "I would certainly feel this one issue India needs to explore and can contribute immensely to our common success". Pm said this at the 20th ASEAN-India Summit, which was led by Indonesian President Joko Widodo and attended by Prime Minister of India, Shri Narendra Modi in conjunction with the ASEAN Summit on September 7. PM Anwar also encouraged economic cooperation between ASEAN and India, especially in concluding agreements like



the ASEAN-India Trade in Goods Agreement by 2025, and leveraging India's agricultural expertise for smart agriculture in the region. The prime minister stressed that climate change cooperation is also essential by focusing on renewable energy, water management and biodiversity conservation. During the meeting, PM Anwar also highlighted India's vital role as a strategic ally, and congratulated the country on the successful launch of Chandrayaan-3. In this regard, PM Anwar remarked, "We share the pride as part of the Asian and ASEAN venture".

Engagements of High Commission of India Kuala Lumpur

The Malaysian Palm Oil Board (MPOB) has signed a memorandum of understanding (MOU) with Indian Vegetable Oil Producers' Association to promote the exchange of vegetable oil sector know-how between the two countries. The MOU with the Indian Vegetable Oil Producers' Association (IVPA) seeks to encourage collaboration between Malaysian and Indian companies in commercial and technical areas. It covers areas, such as sustainable vegetable oil production and trade, technology transfer and capacity building in palm-oil based industries, and promotion of best practices and quality standards. The MOU was signed on August 4, on the sidelines of an industry conference in New Delhi. IVPA president, Sudhakar Desai said that Indian companies can benefit from Malaysia's advanced knowledge in palm oil products and equipment. India is Malaysia's top export destination for palm oil. India purchased 1.22 million tonnes of palm oil in the first six months of 2023, representing 17.3% of Malaysia's export volume for the period.



High Commissioner, Mr. B.N.Reddy visited the Global Solutions Centre of Tech Mahindra at Cyberjaya on 7 August 2023. High Commissioner met Mr. Praful Attavar, Mr. Sajal Mukherjee and the leadership team. Pioneering Indian IT Company in Malaysia since 2003, Tech Mahindra serves leading local corporates, GLCs, MNCs & global clients. Tech Mahindra in Malaysia, with 1,000 personnel (80% Malaysians) contributes hugely to creating local high-quality jobs, exports & local ICT talent development. High Commissioner discussed ways for Indian IT companies to play a larger role in Malaysia's aspiration to develop an advanced digital economy.

High Commissioner delivered the inaugural lecture of The ECKL - Star Diplomatic Encounter Series, organised by Kingslay Strategic Institute for Asia Pacific on 8 August 2023. Dató Seri Mohd Iqbal, Chairman ECKL, Mr. Alex Yeow, CEO of The Star Media Group, Dató Ramesh Kodammal, Chairman AIBC, Tan Sri Michael Yeoh, President KSI Strategic Institute for Asia Pacific addressed the audience. High Commissioner outlined India's rising stature in the global, multilateral and regional affairs, as a force of moderation, as fastest-growing major economy, as current President of G20.



High Commissioner stated that, digital technologies enabled by Government push and private innovation were key in India's economic journey. HC highlighted the huge potential for stronger India-Malaysia ties and the scope to benefit from newer ways of engagement, especially in the areas of digital economy, semiconductors, skilling, healthcare and renewable energy.



Ambassador Vijay Thakur Singh, Director-General, ICWA signed an MoU with Prof. Dr. Mohd. Faiz Abdullah, Chairman Institute Of Strategic & International Studies (ISIS), Malaysia in the presence of Shri BN Reddy, High Commissioner of India on 8 August 2023. The MoU provides for an institutional framework for collaborative activities which will contribute to further strengthening India-Malaysia ties.

On 9 August, High Commissioner met the participants from Malaysia in the 67th Know India Programme who paid a 3 week visit to Delhi & Maharashtra in India. The diaspora youth were keen to learn more about India and stay connected with the roots. Funded by Government of India, Know India Programme welcomes Indian origin youth from across the world for a well-rounded exposure visit to India. KIP has seen regular participation from Malaysia.

High Commissioner met Ts. Mahadhir Aziz, CEO of Malaysia Digital Economy Corporation (MDEC). They discussed possibilities for collaboration between Digital India and MDEC to meet digital economy priorities of Malaysia digital through digital talent development & digital public infrastructure. The next generation collaboration in digital sector between India and Malaysia aspires to build on the large presence of Indian ICT companies in Malaysia, contributing to Malaysian economy through local IT job creation, talent development, service exports, investments and technological excellence.



High Commissioner met the Co-Founders of Curlec by Razorpay, Mr. Steve Kucia and Mr. Zac Liew, the CEO on August 21 2023. They briefed High Commissioner about the exciting journey of their partnership with India's Fintech unicorn, Razorpay and the vast possibilities in the Malaysian digital payment space. Curlec pay, acquired by Razorpay in 2022, is a successful example of India-Malaysia cross country collaboration in the startup space bringing better synergies in the growing digital economy sector in Malaysia, aided by fast paced technological changes in real-time payments in India.

High Commissioner called on Deputy Prime Minister & Minister for Plantation Industries & Commodities of Malaysia, Mr. Fadillah Yusof on 17 August. Discussions focused on deepening India-Malaysia collaboration in palm oil sector, as well as in other Agri-Commodities.



High Commission celebrated the 77th Independence Day at India House on 15 August 2023. High Commissioner, Mr. B.N.Reddy hoisted the tricolour Indian Flag and read out excerpts from the address of Hon'ble President of India. The Patriotic songs and dance presentations were rendered by the students from Global Indian International School & Vikas International School; members of Bharat Club Ladies; and World Malayalee Federation. NRI Women entrepreneurs from KL Business Adda showcased a diverse range of products at India House, which reflected their innovation & entrepreneurial spirit. High Commissioner administered the Panch Pran Pledge for officials of the Mission and over 1,000 Indian nationals. Videos and songs about Unsung Heroes from various parts of India were watched by Indian nationals. Under 'Mitti Ki Khusboo-Mitti ki Yadein' series, curated Videos about various villages of India were screened, that enabled NRI community in Malaysia to connect back with villages across India. Exhibition on Partition Horrors Remembrance Day was organised at India House, which was viewed by over 1,000 members of Indian community.

High Commissioner commended the youth volunteers for their support to GOPIO's activities. High Commissioner paid a courtesy visit on YB Senator Datuk Nur Jazlan bin Tan Sri Mohamed, Deputy President of the Senate of Malaysia on August 25 2023.





Deputy Governor of Reserve Bank of India, Mr. Rabi Sankar met Ms. Jessica Chew, Deputy Governor of Bank Negara Malaysia on August 24. The discussions focused on cooperation between the Central Banks of India and Malaysia and also on cross border digital payments gateways/technologies including deployment of Unified Payment Interface (UPI) and progress on trade settlement in Indian Rupee (INR). 1. India's foreign trade crossed the US\$ 800 billion mark in the first six months of 2023: GTRI

Prime Despite a slowdown in global demand, India's overall exports and imports of goods and services crossed the US\$ 800 billion mark in the first half of 2023, thanks to a robust increase in the country's services sectors, according to the think tank Global Trade Research Initiative (GTRI). 2. NITI Aayog and UNDP have signed a Memorandum of Understanding on fast-tracking SDGs

3. India is the most preferred location for global shared services after Poland and Mexico, says Deloitte survey

According to Deloitte's 2023 Global Shared Services and Outsourcing survey, India has emerged as the most preferred location as a Global Shared Services hub, after Poland and Mexico. The Global Capability Centres (GCC) sector already generates US\$ 60 billion in revenue, and in the next four to five years, it is anticipated to reach US\$ 75-80 billion. An estimated 1,900 GCCs in India are projected to generate US\$ 60 billion in revenue and employ 2 million people. India is one of the leading exporters of services in the world, according to World Trade Organization (WTO) estimates. From 2% in 2005 to over 4% in 2022, the country's share of the global services trade has doubled. This, supported by survey data, demonstrates that shared service centres will be essential to India's efforts to improve its standing internationally and meet its US\$ 400 billion services export goal for the current fiscal year...[read more](#)

4. India moves up to 11th position in global direct selling ranking: WFDSA

India has moved up to 11th position in the ranking of top markets of direct sellers, with retail sales of US\$ 3.23 billion (around Rs. 26,852 crore) in 2022, global industry body WFDSA said in a report. Indian direct selling has registered a growth of 5.4% over 2021 retail sales, said the World Federation of Direct Selling Association (WFDSA) report. On a constant dollar basis, the Indian market attained the highest Compounded Annual Growth Rate (CAGR) of over 13.3% during the last three years, it added. The global direct selling industry reported a decline of 1.5% in 2022 to US\$ 172.89 billion...[read more](#)

5. India is now the second-biggest mobile phone-making country: Counterpoint

India has overtaken China as the second-largest manufacturer of mobile devices in the world, according to a report released by the international research firm Counterpoint. This growth has been fuelled by the Centre's push, increased internal demand, and growing digital literacy. The 'Make in India' initiative's mobile phone shipments from India exceeded 2 billion cumulative units and an annual growth rate of 23% was recorded. Additionally, more than 98% of exports in the overall Indian market were produced in India in 2022, per the data presented, and as compared to merely 19% in 2014, this is a fairly high percentage. In addition, Counterpoint claimed that the Aatma-Nirbhar Bharat (Self-Reliant India), Phased Manufacturing Programme (PMP), Make in India, Production-Linked Incentive (PLI), have contributed to an increase in domestic production and value addition for smartphones...[read more](#)

6. 106% rise in foreign tourist arrivals in India in 2023 for Jan-Jun period

The number of foreign tourists who arrived in India this year during January-June stood at 43.80 lakh, which is 106 per cent higher than the figure (21.24 lakh) for the corresponding period in 2022. 7. India's net-zero transition offers \$12.7 trillion investment opportunity: Report

India's ambitious path towards a net-zero economy by 2050 presents an unprecedented investment opportunity estimated at a staggering \$12.7 trillion, according to the New Energy Outlook: India report by BloombergNEF. The report, which outlines two distinct scenarios for India's energy transition, highlights both the challenges and opportunities that lie ahead. The first scenario, known as the Economic Transition Scenario (ETS), is characterized by an economics-led transition that aligns with a global temperature rise of 2.6 degrees Celsius by 2050. In this scenario, while India makes significant strides towards energy independence and decarbonization, it falls short of achieving these goals by 2050...[read more](#)

Spotlight and Opportunities in India

Insurance Industry



- India's Insurance industry is one of the premium sectors experiencing upward growth. This upward growth of the insurance industry can be attributed to growing incomes and increasing awareness in the industry. India is the fifth largest life insurance market in the world's emerging insurance markets, growing at a rate of 32-34% each year.
- Foreign Direct Investment (FDI) in the industry under the automatic method is allowed up to 26% and licensing of the industry is monitored by the insurance regulator, the Insurance Regulatory and Development Authority of India (IRDAI).
- The insurance industry of India has 58 insurance companies - 24 are in the life insurance business, while 34 are non-life insurers. Among the life insurers, Life Insurance Corporation (LIC) is the sole public sector company. There are six public sector insurers in the non-life insurance segment. In addition to these, there is a sole national re-insurer, namely General Insurance Corporation of India (GIC Re). Other stakeholders in the Indian Insurance market include agents (individual and corporate), brokers, surveyors and third-party administrators servicing health insurance claims.
- The insurance industry in India has witnessed an impressive growth rate over the last two decades driven by the greater private sector participation and an improvement in distribution capabilities, along with substantial improvements in operational efficiencies. The premium in the month of March 2023 for the private life insurance industry grew at a healthy pace of 35% on a year-on-year basis and 20% for FY23.
- The future looks promising for the life insurance industry with several changes in the regulatory framework which will lead to further changes in the way the industry conducts its business and engages with its customers. Life insurance industry in the country is expected to increase by 14-15% annually for the next three to five years. The scope of IoT in Indian insurance market continues to go beyond telematics and customer risk assessment. Currently, there are 110+ InsurTech start-ups operating in India. These startups are expected to provide a major boost to the industry and help increase India's insurance penetration which plays a crucial role in the
