



Significant Diplomatic Engagements

Hon'ble PM addressed G 20 session on Social Inclusion and the Fight Against Hunger and Poverty :

Hon'ble Prime Minister of India, Shri Narendra Modi Ji addressed the opening session of the G 20 Summit on 'Social Inclusion and the Fight against Hunger and Poverty' in Brazil on 18 November 2024. He appreciated the Brazilian G20 agenda focused on Sustainable Development Goals, noting that this approach highlighted the concerns of the Global South and took forward the people-centric decisions of the New Delhi G20 Summit. PM further underscored that the Indian G20 presidency's call for "One Earth, One Family, One Future" continued to resonate at the Rio conversations.



Speaking about India's initiatives to deal with hunger and poverty, Prime Minister noted that India had pulled 250 million people out of poverty in the last ten years and was distributing free foodgrains to 800 million people in the country. Speaking about India's success in tackling food security, PM emphasized that its approach based on 'Back to Basics and March to Future' was yielding results. PM further elaborated on measures taken by India to foster women-led development. Prime Minister also highlighted the steps taken by India to strengthen food security in Africa and elsewhere. In this regard, he welcomed the Brazilian initiative to establish a Global Alliance against Hunger and Poverty, underlining that the Global South was severely impacted by food, fuel and fertilizer crises created by the ongoing conflicts, and therefore, their concerns ought to be given primacy.

On 23 October 2024, Hon'ble External Affairs Minister of India, H.E. Dr. S. Jaishankar met Hon'ble Minister of Economy of Malaysia, H.E. Mr. Rafizi Ramli on the sidelines of the 16th BRICS Summit in Kazan, Russia. Both Leaders discussed the follow up action of the recent meeting between Prime Ministers of India and Malaysia in New Delhi in August 2024, especially in new and emerging technologies. During the visit of the Hon'ble Prime Minister of Malaysia to India in August this year, both countries elevated their partnership to Comprehensive Strategic Partnership.

1. **India's export performance soars with substantial growth across key sectors**

According to commerce ministry data, India's export landscape has shown robust gains in sectors including petroleum, gemstones, agrochemicals, and sugar over the past five years. Notably, petroleum exports hit US\$84.96 billion in 2023, lifting India's share in global trade from 6.45% in 2018 to 12.59%, placing it as the second-largest exporter globally, up from fifth place in 2018. The nation has also taken the lead in exporting precious and semi-precious stones, with its market share growing from 16.27% in 2018 to 36.53% in 2023. This leap propelled India to the top position, with exports rising sharply to US\$1.52 billion from US\$0.26 billion in 2018...[read more](#)

2. **India to see 20 times growth in computing capacity in 2024: Nvidia CEO**

India, a vital player in the global computer industry, is projected to experience 20 times increase in computing capacities in 2024, with aspirations to export significant Artificial Intelligence (AI) solutions, according to founder and CEO of Nvidia, Mr. Jensen Huang. At the Nvidia AI Summit 2024, he highlighted Nvidia's dedication to expanding its ecosystem within India, describing the nation as central to the Information Technology (IT) sector for numerous global companies. He noted the transformative changes occurring in the industry due to advancements in AI, asserting that India is poised to transition from being predominantly a software exporter to a leader in AI exports...[read more](#)

3. **Net FDI in India more than doubles in Apr-Aug 2024, shows RBI data**

Net foreign direct investment (FDI) in India has shown significant growth, more than doubling from US\$ 3.26 billion to US\$ 6.62 billion between April and August 2024. According to the Reserve Bank of India's October bulletin, gross inward FDI rose to US\$ 36.1 billion, up from US\$ 27.4 billion during the same period last year. Repatriation and disinvestment reached US\$ 20.76 billion, compared to US\$ 18.88 billion in the previous year. Approximately two-thirds of the gross FDI were directed towards manufacturing, financial services, communication, and energy sectors. Most of these investments came from Singapore, Mauritius, the UAE, the Netherlands, and the US...[read more](#)

4. **India dominates Global Capability Centres (GCCs) market, now home to 1,800 centres across 240 million sq. ft.**

India is emerging as a prominent destination for Global Capability Centres (GCCs), driven by a robust talent pool and supportive government policies. Currently, over 1,800 GCCs have been established by more than 1,400 unique global occupiers, with over 100 new centres launched in the past two years since 2022, according to data from JLL India. These centres currently occupy more than 240 million sq. ft. of Grade A office space across key cities, including Mumbai, Delhi-NCR, Kolkata, Bengaluru, Pune, and Chennai. This footprint is expected to expand to over 2,300 GCCs, covering more than 280 million sq ft by 2026-27, signalling a new expansion phase in India's business landscape...[read more](#)

5. **India Now Holds 4th Largest Forex Reserves in the World**

With its growing economic strength, India has achieved the significant feat of joining the ranks of the world's largest foreign exchange reserves, securing the 4th position globally after China, Japan, and Switzerland. India has not only become the fifth-largest economy in the world but has also set a new record in terms of foreign exchange reserves. Spotlight and Opportunities in India

Steel Industry in India



- India is the world's second-largest producer of crude steel, with an output of 125.32 MT of crude steel and finished steel production of 121.29 MT in FY23. India's domestic steel demand is estimated to grow by 9-10% in FY25 as per ICRA.
- The growth in the Indian steel sector has been driven by the domestic availability of raw materials such as iron ore and cost-effective labour. Consequently, the steel sector has been a major contributor to India's manufacturing output. The Indian steel industry is modern, with state-of-the-art steel mills. It has always strived for continuous modernisation of older plants and up-gradation to higher energy efficiency levels.
- In the past 10–12 years, India's steel sector has expanded significantly. Production has increased by 75% since 2008, while domestic steel demand has increased by almost 80%. The capacity for producing steel has grown concurrently, and the rise has been largely organic.
- The steel industry has emerged as a major focus area given the dependence of a diverse range of sectors on its output as India works to become a manufacturing powerhouse through policy initiatives like Make in India. With the industry accounting for about 2% of the nation's GDP, India ranks as the world's second-largest producer of steel and is poised to overtake China as the world's second-largest consumer of steel. Both the industry and the nation's export manufacturing capacity have the potential to help India regain its favourable steel trade balance.
- The National Steel Policy, 2017 envisage 300 million tonnes of production capacity by 2030-31. The per capita consumption of steel has increased from 57.6 kgs to 74.1 kgs during the last five years. The government has a fixed objective of increasing rural consumption of steel from the current 19.6 kg/per capita to 38 kg/per capita by 2030-31.

Sri Harmandir Sahib <p>The Golden Temple in Amritsar, also known as Harmandir Sahib, is a breathtaking symbol of spiritual harmony, adorned with a stunning golden façade that reflects in the sacred waters of the Amrit Sarovar. Revered as the holiest shrine in Sikhism, it welcomes people from all walks of life, promoting messages of peace, equality, and devotion.</p>	
2.	Jhallianwala Bagh <p>Jallianwala Bagh is a historic public garden in Amritsar, known for the tragic massacre that took place on April 13, 1919, when British troops opened fire on a large crowd of unarmed Indian civilians. The site has since become a symbol of resistance against British colonial rule and is preserved as a memorial to honor the victims. Today, Jallianwala Bagh attracts thousands of visitors, serving as a poignant reminder of India's struggle for independence.</p>	
3.	Shri Ram Tirath <p>Shri Ram Tirath is a revered pilgrimage site located near the banks of the river Beas. It is believed to be the birthplace of Lord Rama's sons, Lava and Kusha, and holds significant cultural and spiritual importance for Hindus.
