- The firm shall have a Competent Electrical Engineer registered with *Suruhanjaya Tenaga* authorised to work in installation for voltages up to 11kV.
- Tenderers must be registered with *Lembaga Pembangunan Industri Pembinaan Malaysia (CIDB)*
- Tenderers must have completed at least one (1) or more TNB project involving underground cabling installation/relocation works for voltages up to 11KV

Request for Tender document must be accompanied by a Bank Draft or Banker's Cheque for an amount of **RM 212.00** under the name of **High Commission of India**, which is non-refundable.

2. Tenderers are required to undertake a compulsory site visit as per the location details above.

4. The tender documents will be only sold to a “bona fide” representative of the Tenderers. For this purpose, a Letter of authorisation to purchase the Tender Document must be produced by Tenderers representative together with valid “original” and “Certified true copy” (Certified by the Company Secretary or Group A Government Servant) of the relevant registration certificates of “Perakuan Pendaftaran Kontraktor (PPK)” from CIDB to confirm the Tenderer’s qualification.
5. All Tenderers shall observe and comply with statutory requirements, rules and regulations, including any modifications to it or re-enhancement that is enforced by the Government of Malaysia.

  - b) Satisfactory CCRIS report for Company
