I. Envelope -1 shall contain scanned copies of all eligibility information.

II. Envelope -2 shall contain financial bid on the prescribed form.

Envelope -1 shall contain scanned copy of the following (scanned copies to be uploaded)

- a. Cost of the tender in the form of Demand Draft (DD) drawn in favour of Director, Urban Development, Shimla, HP payable at Shimla, Himachal Pradesh.
- b. Earnest Money in the form of Demand Draft / FDR or Bank Guarantee drawn in favour of Director, Urban Development, Shimla,HP payable at Shimla, Himachal Pradesh.
- c. Proof of Technical Qualification.
 - i. The Tenderer shall be a manufacturer / authorized dealer / distributor / agency / Consortium or joint venture partner in India or Abroad of underground / semi-underground bins having manufactured / distributed and installed at least 200 bins in India or abroad in the period of last three (3) years. In order to prove the Technical Experience, the Tenderer shall attach notarized copies of manufacturing license or agency letter / Memorandum of Understanding / authorised dealer agreement or joint venture agreement, as the case may be along with a certificate
 - ii. The Tenderer shall produce a certificate from its client (with an installation of at least 200 bins) in India or Abroad certifying that the underground / semi-underground bins produced by the manufacturer / distributor had a trouble free operating life of not less than 5 years based on their

experience. Notarised copy of the letter from the client as proof of the same.

iii. The Tenderer Supplying and Installing the Underground bins shall have a minimum average annual turnover of Rs. 20 crores or its equivalent in any foreign currency as per the annual financial statements for the last three financial years. And it is mandatory for the tenderer to submit their audited (by the Chartered Accountant / Chartered Accountant firm) final account (Manufacturing cum trading account, Profit and Loss account and balance sheet) so that their declared gross turn over may also be detected and verified. In case of foreign tenderer, all the supportive documents is mandatory to be certified from Foreign Chartered accountants / Chartered Accountant firm and further verified by Indian Chartered accountants / Chartered Accountant firms registered and listed under ICAI (Institute of Chartered Accountant of India)

Envelop-2 shall contain financial bid where Tenderer will quote his offer for each item in the prescribed format in the BoQ through online only.

- 3. The contractor will submit the original in respect of cost of the tender document, Earnest Money. Also Work done certificate including performance certificate, Annual turnover, sales tax / income tax clearance certificate, PAN based Service tax registration certificate, PAN No and TIN No must be submitted before 09.11.2015 upto 11.00 hours.
