Eligibility Criteria of Tenderer/ Contractor

Contractors who fulfil the following requirements shall be eligible to apply. These criteria are indicative. Exact details are available in the tender documents.

The Contractor should have at least seven years' experience in execution of similar:-

- i. Projects in Malaysia, preferably prestigious stone/ monument and allied streetscape works.
- ii. The Contractor should have satisfactorily completed during the last seven years ending 31.3.2015, as per details in the tender.
 - three similar works costing not less than RM 0.56 million each OR
 - two similar works costing not less than RM 0.84 million each OR
 - one similar work costing not less than RM 1.12 million
- iii. The Contractor should have an average annual turnover of at least RM 0.42 million during the last three financial years, as per details in tender.
- iv. The Contractor should have a bank solvency of at least RM 0.56 million.
