The State Government has made special arrangements for the delegates to avail themselves with services at preferential rates at various hotels in and around Gandhinagar.

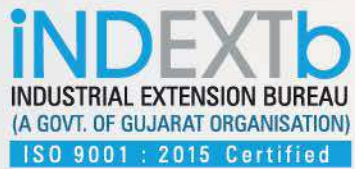
